EFBS ARE DESIGNED TO PROVIDE TEMPORARY FOOD ASSISTANCE FOR PEOPLE WHO ARE IN THE MIDST OF, OR RECOVERING FROM, A CRISIS, SUCH AS A FIRE, FLOOD, UNEXPECTED JOB LAYOFF, SERIOUS INJURY OR ILLNESS. A MAJORITY OF THOSE RECEIVING EFBS ARE LOW-INCOME INDIVIDUALS AND FAMILIES, INCLUDING THOSE WHO ARE ELDERLY AND HOMELESS, BECAUSE THEY DO NOT HAVE FINANCIAL SAVINGS TO HELP THEM WHILE THEY RECOVER. ST. MARY'S 700+ PARTNER AGENCIES RECEIVE THE EFBS AND DISTRIBUTE THEM TO PEOPLE IN NEED WITHIN THEIR COMMUNITIES. EACH EFB PROVIDES A THREE-DAY SUPPLY OF NUTRITIOUS FOOD, WHICH PROVIDES A HELPING HAND WHILE PEOPLE RECOVER AND NO LONGER NEED FOOD ASSISTANCE. ST. MARY'S DISTRIBUTED NEARLY 550,000 EFBS DURING THE
